*Residential Massage Establishments must possess a valid *City of Murrieta* issued “Home Occupation Permit.”

**Freelance Massage is a CAMTC Certified Massage Therapist who lives in the City of Murrieta, or in another city, who wants to perform massage in the city’s jurisdiction. If you are *not* associated with a *local Murrieta massage fixed location*, you cannot practice massage in the City of Murrieta.

Massage Establishments shall maintain a current roster of all employees and independent contractors at all times.

Outcall/Mobile Massage – CAMTC Certified Massage Therapists are employees or independent contractors who perform massage at an *off-site location on behalf of a permitted Massage Establishment*. *The appointment must be booked or arranged by the Massage Establishment, not the therapist directly.*

No massage of any kind can be performed on the premises unless the Owner/Operator or the Designated Manager is present. No exceptions. All establishments must have a Designated Manager; only sole proprietors are exempt.
