

**Virtual Scoping Meeting Guidance  
I-215/Keller Road New Interchange Project**

**MEETING FORMAT**

The I-215/Keller Road New Interchange Project Scoping Meeting will be taking place virtually on the Zoom Platform on **Wednesday, October 19, 2022 from 6 PM to 7:30 PM**. There will not be a physical location for attending the scoping meeting. The public may virtually observe the scoping meeting presentation and offer oral comments once the formal presentation has been completed. The purpose of the meeting is to provide information to the public on the proposed project, describe the environmental review process, and to solicit input from the public on environmental issues and concerns. Attendees will have up to 3 minutes to provide any comments/questions/testimony during the public comment session of the meeting. Only official scoping comments (submitted via email or mail) by **5:00 PM on November 21, 2022** will be summarized in the Draft Environmental Impact Report/Environmental Assessment (EIR/EA).

Please be mindful the meeting will be recorded. A live transcriptionist will also be in attendance of the virtual meeting to transcribe all dialogue.

**MEETING INSTRUCTIONS – OPTION 1: ZOOM PLATFORM**

**STEP 1** – Ahead of the scoping meeting, install the Free Zoom Mobile App or Visit the Free Zoom Website. Prior to the meeting, visit the following link: <https://zoom.us/j/7484273045>

Please note that you may need to obtain an updated version of Zoom in order to access the features that will be utilized within the meeting, such as Spanish Interpretation and Closed Captioning.

**STEP 2** – Select “JOIN A MEETING,” and enter **Meeting ID:** 864-2605-6850 and **Passcode:** 2151019

**STEP 3** – Select Audio Source: Computer Speakers/Microphone

To hear the meeting, ensure your computer speakers are turned on.

**STEP 4** – Your camera will be automatically turned off and your microphone will be muted when you join the meeting. Raise your ‘virtual hand’ to be placed in the queue to speak once the public comment session of the meeting begins. If you do not see the “Raise Hand” icon from the meeting controls, you may have to select the “More” icon first. The meeting facilitator will call one participant at a time and in the order of their request. Participants will be identified by the name provided upon registration for the Zoom Meeting.

Once you have been called on, please select the unmute icon. You will then be requested to state your full name and business or organization. Each comment is limited to no more than 3 minutes. Once you have completed your comment, please select the “Lower Hand” icon and turn your microphone off. All public comments will be recorded and documented. Oral comments are not considered official comments on the scoping process.

**MEETING INSTRUCTIONS – OPTION 2: DIAL-IN AUDIO ONLY (NO INTERNET/ZOOM)**

**STEP 1** – Dial via **Telephone**: +1 669-444-9171 and enter the **Meeting ID**: 864-2605-6850 followed by pound (#). When prompted, enter the **Passcode**: 2151019

**STEP 2** – Your microphone will be muted when you join the meeting. Dial \*9 to be placed in the queue to share your comment once the public comment session of the meeting begins. The meeting facilitator will call one participant at a time and in the order of their request. Participants will be identified by their area code and last three digits of their telephone number.

Once you have been called on, please dial \*6 to unmute your microphone. You will then be requested to state your full name and business or organization. Each comment is limited to no more than 3 minutes. Once you have completed your comment, please mute your microphone and dial \*9 to lower your hand. All public comments will be recorded and documented. Oral comments are not considered official comments on the scoping process.
